Re: No objection to use the trademark "Orkla" in name and logo

Orkla ASA is the owner of the protected ORKLA brand and trademark, including all related intellectual property rights and goodwill (the "**Trademark**") worldwide. The Trademark has been owned and used by Orkla ASA or its predecessors since at least 1904. Further, Orkla ASA is the proprietor of the trademark 'Orkla' registered in India under the (Indian) Trade Marks Act, 1999 bearing international registration numbers 1198028 and 1196433.

This letter sets forth the terms and conditions under which Orkla ASA, hereby grants to its subsidiary, Orkla India Limited ("**Orkla India**"), and its subsidiaries, a non-exclusive, non-transferable, and revocable authorization to use the Trademark, comprising the word 'Orkla' or any part or derivative thereof, including corporate logo mentioned in the **Annexure**, solely in connection with Orkla India's and its subsidiaries' ordinary course business operations ("**Permitted Use**").

It may be noted that Orkla ASA shall remain the sole and exclusive owner of the Trademarks, together with all goodwill appurtenant thereto. Orkla India and its subsidiaries shall not dispute or contest, directly or indirectly, the validity or enforceability of the Trademark nor counsel, procure or assist anyone else to do any of the foregoing.

Orkla ASA retains the absolute right, exercisable in its sole discretion and without the need to state or prove cause, to terminate this arrangement and the Permitted Use of Trademarks granted pursuant to this letter, in whole or in part, at any time, effective immediately upon written notice to Orkla India. Upon any expiration or termination of this arrangement for any reason, Orkla India and its subsidiaries shall, as soon as reasonably possible, and by the latest 12 months from receipt of the written notice, discontinue use, remove or obliterate the Trademarks from its name, corporate logo, and all materials, websites, signage, and advertising then in its possession or control.

Please indicate Orkla India's acceptance of the foregoing terms by having an authorized representative countersign a copy of this letter indicated below and returning such executed copy to the undersigned. This letter shall become effective as of the last date of signature below.
